

# NCIS operational statistics

## Document attachment rates – 1 July 2021

The NCIS Unit provides updated statistics about document attachment on a quarterly basis to assist users in interpreting search results.

Statistics contained in this report are correct as of 1 July 2021.

### By jurisdiction and document type

The level of document attachment varies within the NCIS according to the reporting jurisdiction. Document attachment is dependent upon the status of the case (often not available until the case is closed) and jurisdictions' ability to provide an electronic copy of documents for upload to the NCIS

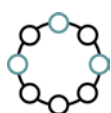
The NCIS Unit continues to work with participating jurisdictions to increase the availability and coverage of information on the NCIS
